Home Mailbox Parcel

Home Mailbox Parcel is a letter with maximum weight 5 kg.

Home Mailbox Parcel is only valid from Norway to Norway. Home Mailbox Parcel must have a harmonized label, which has an EDI barcode. Barcode will be read when received at terminal and delivered at the mailbox. If the customer wants more tracking they need to use an RFID tag.

- If the Home Mailbox Parcel (3570 and 3584) is too big for the mailbox it will be sent to nearest manned pickup point.
- If 1081 is activated from sender/receiver then we will deliver outside the door.
- If 1280 is activated from sender then we will deliver to nearest manned pickup point.

9650 is valid with 1073 Pickup at the mailbox. Specific dates are not possible for the pickup. Bring will do the pickup at the nearest possible date from receiving the pickup request.
