1 Introduction

From 2019 Posten and Bring will implement some revised services for existing and new customers. This document describes the first set of services that will be launched for customers. Moving existing customers from their current solutions to the revised services is to happen according a plan on a customer level agreed upon between Bring, the customer and the integration partners where relevant. Please contact us on integrasjon.norge@bring.com for questions or information regarding label specifications. The current services are still in use and the documentation is being updated on developer.bring.com/edi

In 2019 and 2020 Bring will offer services that are to use UPU labels and S10 barcodes. This is because of Brings partners in the Nordic countries and rest of the world. Posten Norge AS also cooperates with other Post companies in the UPU, Universal Postal Union.

This specification is a description of the labels for marking goods and parcels for transportation by simultaneous use of EDI. To which countries you can send packets with EDI, we refer to the applicable specifications for EDI file formats and Appendix2 and 2A.

The label is designed according to the CEN EN 1573 Multi-industry Transport Label. For more information follow the link below:

From June 2022 we also move label spesification for Courier and Home Delivery (furniture and more special handling) to this specification. So that we in some time can only have one. The EDI is not changing and can't be used as revised services. Very important. So like 2870 services will still use TDT = BEX and TSR = HUB.

2 Content

3 Dimension

The most useful standard dimension for the label is 101x192mm. This specification is based on this dimension.

It is also possible to use other dimensions, for example, a width of 148mm.
But the minimum height is 192mm.

4 Material

The label should have a material that is durable, and the package's underlying structure does not affect the readability of barcodes. More about barcodes in next chapter 5 "Quality".

5 Quality

In addition to good quality of the barcode, it's important how the label is placed on the consignment. To maintain a good delivery quality, the barcode must be located so that the entire barcode is displayed, without wrinkles or folds.

Do not place tape above the barcode.

The print quality should be without tears or blurred lines.

To achieve good quality, the printers must be cleaned at least once a week.

6 Barcodes

6.1 Description of GS-1 128

The barcode should, depending on the content, be of symbology GS1-128 according to GS1 / UCC standard, Code 128 according to EN 799, X-module a minimum of 0,375 mm, height at least 22 mm. Readability should be tested and be satisfactory after CEN EN1635 standard, quality (overall) minimum ANSI B (according to ANSI X3.182:1990).

The CEN license plate requires the use of standard identifiers to describe the use of the barcode. When GS1-128 code is used, it should be an application identifier (00) ahead of the barcode for the License plate-number. This code also contains identifiers for packaging type, country, and shall also contain the customer number in GS1. Including the code identifiers, the License plate-number consists of 20 numeric characters.

6.2 Description of Code 39

This section will be updated when Bring activates revised service for abroad. Posten and Bring will have partners and cooperation with other Post companies around the world.

Regarding Parcels, until further notice, only Code 39 can be used as barcode symbol and UPU's S10 standard for content.

The bar code shall be of symbol code 39 according to EN 800 Quality ANSI B, X module 0375 mm and the ratio 2.33:1 or 2.0:1, height 22 mm. The customer is obliged to order a new number series at the Post Office, at least two weeks prior to the current number series is expected to be exhausted.

Readability should be tested and be satisfactory after CEN EN1635 standard, minimum ANSI B

6.3 FACT standard

Only for special use in Posten/Bring. Requires agreement.

FACT standard, which uses Code128, also contains identifiers. For the License Plate it will be 3J when EDI is used. This code can contain up to 35 alpha-numeric characters.

6.4 Use of barcodes in Posten/Bring

GS1-128 is used for all transport domestic.

For transport abroad for the parcel service is it code 39 (S10). This section will be updated when Bring activates revised service for abroad. Posten and Bring will have partners and cooperation with other Post companies around the world.




Figure 1: Field description

The font should be Arial, Gill Sans or Sans Gentle, or fonts with another term that gives almost the same look. If it is indicated in fonts in bold, the font will be Arial Narrow bold / Gill Sans Bold / Gentle Sans bold, or another clear sans serif font. General size is set to 10 - 12 points. The prompts are set to 8 point.

In the examples and the font in this specification is in Arial.


