

Changelog for Revised Services – Bring Norway Domestic, parcels and cargo.

Last update: March 15 , 2023.

This is a document we will send our clients and integration partners who are implementing our revised Bring-services. When the new version of the documentation below is being launch again, all these changes will be updated. But since we cannot send out new versions all the time, this log will describe errors, missing and better documentation until the next version.

1 Changes in March 2023:

1.1 Return Services – business parcels

Added a new service 9350 – Return to business.

2 Changes in November 2022:

2.1 Home Delivery

VAS 2012 Same day delivery. Customized service. Please contact sales or integration team for requirements before setup and use.

2.2 Business delivery

VAS 1142. A phone-number is mandatory when using this VAS.

Service 5000 is now allowed with VAS 1036 - Choice of pickup point.

2.3 Delivery to Pick-up-Point

Adding service 1371. As informed from Bring, Posten. <https://www.posten.no/en/receive/flexibility/pickup-deadlines> or <https://www.posten.no/motta/fleksibelt/hentefrister>

In the Postens iOS and Android app or at Posten.no the recipient can extend from 7 to 14 days. To prevent this option/extended time at a pick-up point, the consignor can add VAS 1371 to the order. Customer can contact sales or integration team to discuss options here.

Maximum dimensions for parcels to be placed in a pick-up locker is:

"length": 44.5 cm
"width": 50.5 cm

"height": 60.0 cm

We strongly recommend all EDI/TA vendors and customers to support the limitations when displaying the pick-up options. The API for Pick-up locations is updated with info om "manned" or "locker" locations. Use this flag for filtering the API-response/options based on the package size to ensure display of the relevant/correct location options in your GUI's and for the webstore checkout.

2.4 Service 5200 – Early Delivery, Cargo (before 7am)

Service is no longer available.

3 Changes in Sept 2021

3.1 Letter-services

Removed VAS'es 3067, 3236 og 3190

Removed VAS 0041 for PUM.

3.2 Mailbox-Delivery

9650 is a change from earlier but please add if it is not yet available in your system.

3.3 Delivery to Pick-up-Point

Not a valid combination. 1036 - Value Added service (VAS): mandatory use of Pickup Point API. To support this properly it is very important to use a Bring pickup point ID, as described in Appendix 2a.

Value added service 1036 for service 5800 not applicable/valid when using pick-up locker locations. Our systems does not allow driver to deliver in pickup-locker. Several Posten delivery-points are pickup-lockers, identified by categories in the PuP API response. Note that 1036 is available together with 1134 "Personal delivery", but will be redirected to a manned pickup-point. This also applies for VAS'es 1063, 1083 and 1082 etc. Customers and/or TA-vendors is advised to activate a pop-up message or similar in the GUI for info, and support filtering for parcel lockers using the "PickupPointType" info in Bring API-responses - "Manned" or "locker". Please see <https://developer.bring.com/> for details.

In the API-response you receive max length: 44.5cm, width: 50.5 and height: 60.0 for the lockers. This can be used to filter our pickup-points based on parcel size, thus preventing failed bookings during checkout due to exceeding the requirements.

3.4 Home Delivery

New VAS'es 1280 and 1283. Add this to your system if required/upon request.

Other changes: check details in appendix 2.

3.5 Business delivery

Business Pallet, service 5400 is added. Please add this. Label spec is updated. Need to be "locked" ie only for customers with service-specific agreements where this service is included. As long as your customer number is valid and used with Bring Shipping-Guide API, the API-response will list 5400 only for applicable customers.

5000 services. A receiver can re-route an order to a different pick-up point using Posten/Bring websites. If the consignor don't want this functionality/option for the consignee, VAS 1280 should be added to the order.

3.6 Express

Removed VAS 2141.

3.7 Returns

Removed VAS'es 2101, 2141, 2261.

An updated Label should include a prioritization-code for handling. Please see updated labelspecifications for services 9000, 9100 and 9300. Code (field AD)

- Added handlingcode "T" on the label when using VAS 1083 – Thermo.
- Please add new VAS 1283. The display of this VAS is not required on labels.
